

ONLINE LEARNING: STUDENT CODE OF CONDUCT



Introduction

1. St Joseph's College Geelong recognises that its students use technology for personal and educative reasons, particularly when studying remotely. In particular, there will be times when students are required to engage in online learning in conjunction with or instead of traditional face-to-face learning. This could include online lessons, communication with teachers, staff members and other students online in an educational environment, using school technology and completing assessments online.

This Online Learning Student Code of Conduct sets out standards of behaviour and expectations that apply to all students when they are using:

- (a) school associated online platforms such as Zoom, Microsoft Teams, Google G-Suite including Classroom and Hangouts Meet, Echo and Simon, or
- (b) school provided laptops, iPads or other technology such as school internet or Wi-Fi, including on their own personal devices.

This Code of Conduct applies to students when they are using any school platform or technology both at school and outside of school.

The Online Learning: Student Code of Conduct complements the existing policies and agreements regarding information and communication technologies available on the SJC Website.

2. General Principles

When students are engaging in Online Learning, they are expected to behave in the same manner as if they were at school. During school hours, students should remain focused on school work and avoid distractions such as using their phones. Failure to attend scheduled online lessons or submit online assessments will be treated in the same manner as failing to do so while attending school.

Even if students are at home or not at school when using school platforms or technology, they are expected to act respectfully and politely towards school teachers, staff members, students, external educators and other members of the school community. Students must continue to comply with all other relevant student policies, guidelines and expectations.

Students should be aware that the school can access and keep records of communication that takes place on school platforms or technology. The school also reserves its rights to access a student's school accounts if it believes that there has been a breach of this Code of Conduct or any other school policy. Students are expected to cooperate with any investigation by the school or regulatory authority.

3. Expectations of behaviour

In relation to Online Learning, all students must:

(a) use School platforms and technology for school purposes only, including education and co-curricular activities;



- (b) comply with all reasonable directions provided by school teachers and staff members;
- (c) attend and participate in the required school lessons and classes that take place online;
- (d) ensure that they have the proper school platform and technology required to attend online classes and complete school work online or notify relevant teachers and school staff;
- (e) continue to complete all homework and assessments online as directed by teachers and staff members;
- (f) regularly monitor online platforms to remain updated on developments, tasks, lessons and school communication;
- (g) not engage in disruptive behaviour when participating in online lessons such as excessive background noise;
- (h) log off the school platform after use, especially being mindful to turn off any video or voice recording capacity;
- (i) when participating in online classes with video:
 - (i) be properly clothed in school uniform or other appropriate attire as required by the school:
 - (ii) be in an appropriate location where possible (e.g. students should be seated at a desk, not lying on their bed); and
 - (iii) ensure that there is no inappropriate background or material present in the video; and
 - iv) use an appropriate digital background/effect to minimise the risk of any other person's image being transmitted.
- (j) only use approved school platforms to communicate with teachers and school staff members.



4. Prohibited behaviour

All students must **not** engage in the following behaviour:


- (a) any form of cyberbullying, harassment, discrimination or vilification using any school platform or technology;
- (b) use of school platforms or technology to access or distribute inappropriate, sexual or graphic material;
- (c) use of social media on any school platform or technology;
- (d) excessive use of school platforms or technology for personal socialisation with other students, including the organisation of social events;
- (e) engage in any form of sexting, image based abuse or inappropriate behaviour using any School Platform or Technology;
- (f) use any School Platform or Technology for any act which could be a breach of law;
- (g) allow an individual not associated with the school (e.g. a student of another school) to access the student's school accounts, including through sharing passwords;
- (h) share confidential links or access to any school platform or technology (e.g. sharing a link to a school online lesson);
- (i) record or take photos of any online communication, video, lesson or recording, including screenshots, unless permission has been granted by the school;
- (j) use of any school platform or technology that is not in accordance with the school's values or causes harm to another individual; and
- (k) access a staff member or another student's school accounts.

5. Consequences of a breach

Students that breach this Code of Conduct may be subject to disciplinary action. This may include behaviour demerits being recorded on SIMON leading to disciplinary and restorative meetings online with parents/carers and Year Level/House Coordinators, Heads of School or Deputy Principal. High level behaviour could result in Saturday detention, suspension, removal of access to school platforms and technology or exclusion.

The Australian Government have also recently created on-line reporting pathways https://www.esafety.gov.au/ which can support students and teachers who receive any form of cyberbullying, harassment, discrimination or for students who access and distribute inappropriate, sexual or graphic material. These particular cases will be referred to the e-Safety Commissioner and/or the Police.

- We should aim to make a difference in someone's day.


RESILIENCE
